L&TMRHL WINS TRIPLE HONOURS, CROWNED PPP PROJECT OF THE YEAR AT ET NOW INFRA FOCUS SUMMIT 2025

L&T Metro Rail (Hyderabad) Limited (L&TMRHL) has achieved a landmark month of recognition, winning **three prestigious national awards** that reaffirm its position as India's most successful metro rail project under Public-Private Partnership (PPP).
