For submission of online Bid, Bidder should login to third party portal <https://npl.abcpocure.com/> with encrypted class 3 Digital Signature Certificate (DSC) in the name of Authorised Signatory issued from any of the licensed Certifying Agency (CA). 2. The Tender document fee is not applicable; and anyone can download Tender Document by registering themselves in third party Portal appointed by NPL i.e. <https://npl.abcpocure.com/> or <https://www.nabhapower.com/tenders/coal-procurement-tenders/>
3. Issuance of Tender Document to any Bidder shall not construed as pre-qualification of such Bidder.

5. The EMD shall be deposited on or before the schedule date and time, as mentioned above. Any bid submitted without the requisite EMD shall be treated as non-responsive and liable for rejection.
6. Requests lacking complete information or not communicated within the stipulated deadline shall be liable for rejection and will not be considered further.
7. Bidders are advised to carefully read all instructions contained in the Tender Document before submitting the Bid.
8. The complete Tender Document, along with supporting annexures, shall be uploaded at the time of online submission of the Bid.
9. Bidders are advised not to wait until the last date for submission and to submit their Bids at the earliest. NPL shall not be responsible for any interruption/technical snag in website, and no extension for submission of Bid shall be allowed unless otherwise NPL extends the dates.
10. **Procedure of bid opening:** For submission of bids, the scheduled date and time of Bid submission closing shall be treated as the cut-off deadline, after which the Bids shall be frozen. The online bidding system will not permit submission of Bids after the specified expiry date and time. The Technical Bids shall be opened by the Tender Committee or their authorized representatives.
11. After Technical Bid opening, the bids shall be evaluated for meeting both the qualifying requirements- Technical & Financial. And only those bids complying with the Qualification Criteria shall be considered for Price Bid opening.
12. NPL reserves the right to accept or reject any Bid, and to annul the tender process and reject all Bids at any time prior to award of Contract, without thereby incurring any liability to the affected Bidder(s) or any obligation to inform the affected Bidder(s) of the grounds for the NPL's action. The decision of NPL in this regard will be final and binding.

3	Bidder must have an Average Annual Turnover of not less than Rs. 20 Crores during the last three financial years. (i.e. FY 22-23, 23-24 & 24-25)	Audited Balance Sheets (Income statement / P&L)

1. Bidder shall submit supporting documents for services they are bidding for, i.e., -
  - a. Experience of relevant service, if they are bidding for one system- AHP or CHP,
  - b. Experience for both systems, if bidding for both- AHP & CHP.
2. Relevant Experience:
  - a. For AHP: Bidders should have carried out mechanical maintenance (preventive, predictive, corrective & breakdown maintenance), operations and housekeeping for bottom ash slurry, bottom ash hopper, fly ash vacuum conveying system, silo equipment inclusive of ash unloading, silo fluidizing air system, service water, repair / replacement of damaged air, water and ash slurry conveying pipelines, bottom ash hopper make-up water systems, ESP fluidized air blower, compressor & accessories.
  - b. For CHP: Bidders should have carried out mechanical maintenance (preventive, predictive, corrective & breakdown maintenance), operations and housekeeping of automated CHP Plant for wagon tippler with side arm charger, apron feeder, crusher, conveyors, stacker cum reclaimer, dozers, air compressors, etc.
