3. Issuance of bid documents to any Bidder shall not construe that such bidder is qualified.

10. **Procedure of bid opening:** For submission of bids, the time and scheduled Bid Submission Date shall be treated as cut-off-line, and accordingly, the bids shall be frozen. The online bidding system will not allow bid submission after the respective specified expiry date and time. Make sure the bid submission is completed well in advance of the time. NPL shall open the technical bid and evaluation shall be done.
11. After Techno-commercial bid opening, the bids submitted shall be evaluated for meeting both the Qualifying Requirements & Technical Requirements and only those bids meeting the Qualifying Requirements and complying with the Technical Requirements shall be considered for Price Bid Opening.
